REGULAR MEETING

CALL TO ORDER: The Regular meeting of the Cedaredge Planning & Zoning Commission came to order at 7:00 P.M.

STAFF PRESENT: Chairman Jarbo took roll of the attending staff, those present included Town Clerk William Warner, and Town Administrator Kathleen Ann Sickles. Public works Director Jerry Young had been excused from the meeting, and Intern Greg Brinck was absent at roll call.

PLEDGE OF ALLEGIANCE: Chairman Jarbo led those present in the Pledge of Allegiance.

MINUTES JUNE 7, 2016 REGULAR MEETING: Chairman Jarbo asked if there were any objections to the Record of Proceedings June 7, 2016. No objections were made, Welch motioned to pass the minutes, and Helbert seconded. With a move and a second the minutes were accepted.

DELTA COUNTY PLANNING: SUB 16-011 APPLE VALLEY SUBDIVISION: At this time Intern Greg Brinck arrived to the meeting. A discussion was held by the commissioners to determine what the commission would do in regards to the Apple Valley Subdivision's need to obtain a water tap. The Commission decided that there roll would be to recommend to the County the need of a water tap at the subdivision. Anderson Moved to recommend to the county that Apple Valley Subdivision acquire a water tap. Helbert Seconded the motion, and the motion passed unanimously.

SIGN APPLICATION: The commission discussed a fee for off premise sign application. A fee not to exceed \$50 was settled upon by the council. Naslund moved that the Commission proceed with a fee not to exceed \$50, Anderson seconded the motion. The Motion passed unanimously.

REVUE MISSION STATEMENT: The Planning & Zoning Commission mission statement was read and reviewed. No member had a desire to change the mission statement. It was determined that the mission statement would be read at every meeting following the pledge of allegiance.

PLANNING AND ZONNING COMMISSION VACANCIES: Chairman Jarbo mentioned a party potentially interested in joining the commission. No other news


