May 5, 2020
Record of Proceedings

Commission Chair Walt Anderson called to order the Regular Meeting of the Cedaredge Planning & Zoning Commission at 6:02 p.m. and led the Pledge of Allegiance. The meeting was held virtually via Zoom. Present were Commissioners Walt Anderson, Terry Jarbo and Larry Naslund; Mayor Raymond F. Hanson; Town Administrator Greg Brinck and Town Clerk Kami Collins. Absent and excused were Commissioners James Ayers and Richard Cartin.

Chairman Anderson asked Kami to read the vision and mission statement.

Minutes: February 4, 2020 Regular Meeting: Chairman Anderson asked Kami to read the minutes. He asked for a clarification on the November date; Kami will send the information to the Commission. Mayor Hanson moved and Commissioner Jarbo seconded to approve the minutes as presented; motion passed unanimously.

Letter of Interest: Bob Michael: Bob Michael submitted a letter of interest to serve on the Commission. Commissioner Jarbo moved and Mayor Hanson seconded to recommend to the Board of Trustees that Bob Michael be seated on the Commission.

Virtual Planning Refresher Workshop by Community Development Office: Administrator Brinck announced the upcoming training.

Chairman Anderson mentioned that Commissioner Terry Jarbo's term ends in June. He asked Mr. Jarbo to consider serving another term on the Commission. Mr. Jarbo indicated he would like to serve another term.

Mayor Hanson indicated he had someone interested in the vacant position.

Administrator Brinck indicated he has a couple of land use applications that are in the works that will come before the Commission later this summer. In June, Town Planner Davis Farrar will conduct a planning training.

Chairman Anderson reminded the Commission that a new chairperson will be seated at the June meeting.

Commissioner Jarbo moved and Mayor Hanson seconded to adjourn the meeting; Chairman Anderson adjourned the meeting at 6:23 p.m.
